Agenda 1 To discuss list of activities to be organized under IQAC.

It was discussed and proposed that several activities can be organized at the institutional level and the university level. Some of the activities include:

- Identification of Benchmark standards and practices for IITE.
- 2. Developing a feedback mechanism for students and faculty.
- 3. Upgradation of existing curriculum and compiling curriculum of 2011, 2013,2015 and 2018
- 4. Compilation of all the old question papers year wise and placed in library for the viewing of the students and teachers.
- 5. A strong system for the performance appraisal of academics and administrative staff is to be developed.
- 6. Standards for teaching learning process to be defined in terms of Program outcomes and course outcomes
- 7. Equip prospective teachers with the knowledge and competences of digital pedagogical strategies.
- 8. Promote interface through seminars, workshops etc.
- 9. Documentation process for various programs should be done in an organized manner.
- 10. Develop practices for analysis of assessment and evaluation practices. Develop mechanism for feedback on evaluation, remedial and mentoring.
- 11. Provision may be made to prepare for NAAC and conduct of Academic and Administrative Audit (AAA)

It was discussed and proposed that develop the Performa for Faculty appraisal report and Performance appraisal report. Develop quarterly mechanism for collection and presentation of FAR and PAR.
