The draft for CAS Performa was presented for discussion. It was proposed that CAS Performa should be in accordance with the UGC Regulations 2014.

After discussion it was proposed to submit a proposal of credit transfer to UGC for the transfer of credits through ANGIRA Portal. Further it was proposed to prepare list of subject wise coordinator for ANGIRA and also Shiksharth Videos can also be used for developing further the four quadrants.

After discussion it was proposed to start the preparation of NAAC Accreditation. For this following points were proposed:

- IQAC should plan NAAC Zonal Workshops at five centers for sensitization of affiliated colleges
 towards NAAC Manual for Teacher Education Institutes. All the affiliated colleges are to be
 divided in five zones and 1 NAAC accredited college in each zone will function as zonal center for
 organization of workshop. Each center will get Rs. 20,000/- for organization of workshop.
- 2. IQAC should plan NAAC Workshop for IITE for sensitization of academic and administrative staff towards NAAC University Manual.
