Resolution-2 Action taken report of minutes of the 17th meeting of the Academic Council

dated 25.03.2022 was approved.

Resolution-3 Revised Academic Calendar for 2021-22 and Academic Calendar for 2022-23 were approved by the Council. Same have been circulated for implementation by the Academic Branch.

- Resolution-4 Admission Brochure for Admission-2022 was discussed and approved by the Council. Sam has been implemented for the Admission-2022.
- Resolution-5 An updated list of Subject Experts for appointment of Assistant Professor/ Adhyapak Sahayak at affiliated colleges of the IITE was discussed and approved.
- Resolution-6 The issue of non-payment of fees by PhD Scholar Chetankumar Patel was discussed by the Council. As per the decision taken, Scholar has submitted his fees due. Centre of Education has also collected fees due from other two PhD scholars Shweta Joshi and Prashant Trivedi.

Council had taken note of the procedural lapse of the Regulations by Centre of Education. It was decided to give instruction to Centre of Education to take utmost care to follow regulations and to avoid such cases in the future. A letter has been issued to the Centre of Education for the same.

- Resolution-7 Online Application Charges for various academic programmes for Admission-2022 for the Admission-2022 purpose, proposed application and processing fees were presented before Council and same were forwarded with recommendation to the Executive Council for discussion and approval.
- Sanction of grant from ICSSR to Dr. Jayna Joshi, Dr. Jyoti Raval and Dr. Resolution-8 Sudhirkumar Tandel: Academic Council had taken note of sanction of grant form ICSSR.
- The issue was discussed at the meeting and it was decided that student Resolution-9 should be granted his term as per the norms, but he should be allowed to appear in the University Examination only after he clears all previous ATKT. Centre of Education has taken necessary steps accordingly.

Council had decided to give instructions to the Centre of Education for such cases as per the regulations so that such cases should not arise in the future. A letter has been issued to the Centre of Education for the same.

- Resolution-10 The Council discussed and approved action taken for internet lease line at IITE Campus. The council also approved the draft MoU signed under NKN (National Knowledge Network) Project, for 1 GBPS internet lease line provided by RailTel Corporation of India Ltd.
- Resolution-11 The Council had taken note of Inauguration of Calendar 2022 "Nadi ko jano".
- Resolution-12 The Council had taken note of the first state level TLM Competition
- Resolution-13 The Council had taken note of the request sent to the Director General, BISAG, Gujarat for the allotment of dedicated channel to IITE.
